RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose, the Rio Blanco County Fairgrounds (premises), herein defined as including but not limited to the grandstands, the arena, race track, chutes, pens, areas reserved and intended for participants or restricted to the general public, all walkways, concessions, multipurpose building, or any area appurtenant to any areas where activity related to any event shall take place, or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in any event, the undersigned, for himself, his personal representative and heirs, acknowledges, agrees and represents that he has or will immediately upon entering any of such areas, and will continuously thereafter, inspect such areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such areas and his participation, if any, in any event, constitutes an acknowledgement that he has inspected said area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees that if he feels anything to be unsafe, he will immediately advise the officials of Rio Blanco County of such and will leave said area.

THE UNDERSIGNED AGREES AS FOLLOWS:

1. The undersigned hereby releases, waives, discharges and covenants not to use Rio Blanco County, its officers, agents or employees, any subdivision thereof, or owners or lessees of the premises, used to conduct any event and each of them, for any and all loss or damage and claim or demands therefore on account of injury to the person or property or resulting in the death of the undersigned, whether caused by the negligence of the undersigned or otherwise, while the undersigned is in or upon the premises.
2. The undersigned hereby assumes full responsibility for any risk of bodily injury, death or property damage, due to the negligence of the undersigned while in or upon the premises while competing, officiating, observing or working in any event.
3. The undersigned hereby agrees that the activities of an event may be dangerous and involve the risk of serious injury and or death and property damage. The undersigned further expressly agrees that the foregoing Release and Wavier of Liability and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Colorado and that if any portion hereof is held invalid, it is agreed that the balance shall continue in full force and effect.
4. The undersigned states that he has read and voluntarily agreed to sign this Release and Wavier of Liability and Indemnity Agreement and further agrees that no oral representations, statements or inducements apart from the foregoing agreement have been made to him and that he fully understands this agreement.

For the purposes of this agreement, the male gender shall also include the female gender.
